## TERMS AND CONDITIONS OF PURCHASE ORDER

Alberta Breeder Finance Inc. hereby authorizes the above-described Auction Market and/or Licensed Livestock dealer to purchase the livestock on the following terms and conditions.

- 1. Only female breeding Livestock may be purchased pursuant to this Purchase Order. No feeder livestock may be purchased.
- Trucking Expenses plus GST thereon and any amount above the maximum average purchase price per head must be paid by the Livestock Producer. Eligible expenses that can be included with the purchase price can include branding, commissions, pregnancy testing, vaccinations and clearing charges.
- 3. All purchases must be invoiced to Alberta Breeder Finance Inc. "on account of" the Livestock Producer.
- 4. The Livestock must be in good health and must meet the specifications set forth above on delivery to the Livestock Producer.
- 5. All Livestock subject to the Purchase Order shall be branded by you with the Alberta Breeder Finance Inc.'s registered brand, being shelter over triangle as indicated on the front of this Purchase Order (in the case of Ewe Lambs and Yearling Ewes, tagged with ABFI tags in left ear), before delivery, or by the Livestock Producer immediately after delivery. Please contact the Local Feeder Association for specifications with respect to brand location and any identification marks. Alberta Breeder Finance Inc. will not be obliged to pay for the Livestock until they have been branded and inspected by the Feeder Association's local supervisor and have been delivered to the Livestock Producer.
- 6. The Supplier will notify both the Feeder Association and Alberta Breeder Finance Inc. of the delivery of the Livestock to the Livestock Producer by providing a copy of the invoice by delivery, facsimile transmission or e-mail. The Alberta Breeder Finance Inc. agrees to have its local Feeder Association supervisor inspect the Livestock within 2 business days of receipt thereof.
