The undersigned acknowledges and agrees that the livestock inspection services are subject to the following Terms and Conditions:

- a) This request for livestock inspection services is subject to approval by the head office of Livestock Identification Services Ltd.(LIS)
- b) The cost of the livestock inspection services is the total of the inspection fee and the expenses incurred by LIS in providing the inspection services. The inspection fee will be calculated on either a per-head or a per-hour basis whichever is greater. The per-head rate, the hourly rate and the expense costs are as follows:

- c) The person requesting the inspection must ensure that:
 - (i) the facilities (pasture, corrals, alleys, pens, chutes and gates) are adequate and appropriate for the purpose of performing the inspection to be carried out;
 - (ii) the Livestock Inspector is given whatever assistance is reasonably necessary to enable the inspector to carry out the inspection in a safe and efficient manner;
 - (iii) all livestock being inspected are confined in an area suitable for the type of inspection requested; and
 - (iv) where sunlight is inadequate, artificial lighting is provided.
- d) The Livestock Inspector may refuse to carry out the inspection if the facilities are not adequate or if the inspection cannot be carried out in a safe and efficient manner. If this

occurs, the person requesting the inspection will be invoiced for mileage and time for the Livestock Inspector to attend.

- e) An invoice for the livestock inspection services will accompany the Livestock Inspection Report and is payable on receipt. LIS may request a payment in advance of the inspection.
- f) The results of the inspection will reflect the findings of the Livestock Inspector on the date the livestock inspection services were completed and will be subject to the limitations set out in the Livestock Inspection Report. The undersigned agrees that the Livestock Inspection Report will be used solely for the above noted purpose, by the above noted person, and for no other purpose and by no other person.
- g) The person requesting the inspection acknowledges and agrees that LIS, its officers, directors, employees or agents (hereinafter referred to as "LIS") shall not be liable to that person or that person's officers, directors, employees or members or its lenders for any act or omission or for any breach or non-performance in carrying out the inspection or in preparation of the report whether the act, omission, breach or non-performance was caused by the negligence of LIS or otherwise.
- h) The undersigned agrees that no action or proceeding will be commenced by the person requesting the inspection or anyone associated with that person against LIS or any Livestock Inspector or LIS employee for any act or omission or for any breach or non-performance in carrying out the inspection or in preparation of the report whether the act, omission, breach or non-performance was caused by the negligence of LIS or otherwise.
- i) The person requesting the inspection agrees to indemnify and save harmless LIS and its directors, officers, employees, and agents (collectively referred to as LIS) from and against any and all claims, demands, damages, losses, costs, charges, expenses, actions, and causes of action of any kind, including (but not limited to) legal fees on a full indemnity basis, which may be made or brought by anyone against LIS now or in the future, arising from any act or omission or from any breach or non-performance in carrying out the inspection or in preparation of the report whether the act, omission, breach or non-performance was caused by the negligence of LIS or otherwise.
