ADVANCE WORKSHEET FOR LIVESTOCK - AGRISTABILITY OPTION

A. LIVESTOCK ADVANCE

In this Worksheet, Western Cash Advance Program Inc. is referred to as either "WeCAP" or the "Administrator". Other APP administrators are referred to as "other Administrators".

This Advance Worksheet may be used by Livestock Producers who wish to secure their Advance with an assignment of their AgriStability benefits. This Assignment, and documentation concerning the Producer's AgriStability enrollment indicated below, must be submitted with the Application. Advance is not limited by the security; however, Producers must always maintain the security coverage until the APP Advance has been fully repaid.

The Producer must not have more than one million (\$1,000,000) outstanding in Advances, including as a result of the overlap between Program Years. Advances amounts issued above the first two hundred fifty thousand (\$250,000) issued in the Program Year shall be interest-bearing and will be limited by other interest-free amounts issued to the producer and/or Related Producers. Advance amounts issued above the first two hundred fifty thousand (\$250,000) issued in a Program Year shall be interest-bearing.

For Continuous Flow Operations, only one twelve (12) month Continuous Flow Operation Advance Cycle is allowed per Program Year.

Producers must submit their Statement of Inventory worksheet, 2023 AgriStability Program Enrolment/Fee Notice and Proof of Payment, AgriStability Production Margin summary, including schedules 2&3 for 2020 and 2021.

Livestock must already be born to be eligible for an advance. Advances will only be issued on Livestock that the Producer expects to be marketed by the end of the Production Period.

2. Definitions and Interpretations

- "AAFC" means Agriculture and Agri-Food Canada
- "APP Electronic Delivery System" means the on-line system which electronically enables the submission of data relating to the delivery of the APP between AAFC and Administrators;
- "Business Risk Management Program" or "BRM" Program refers to any program listed in the schedule of the Agricultural Marketing Programs Act, that can be used to secure an advance;
- "Default" means, when used in relation to a Producer, that a Producer is considered in default under a repayment agreement according to Section 21 of the AMPA.
- "Producer" means the individual, partnership, corporation, or cooperative that applied for an advance under the Advance Payments Program.
- "Repayment Agreement" means the agreement signed by the Assignor and the Administrator outlining the terms and conditions of the Assignor's Advance under the APP

3. Assignment

- The Parties hereto agree that:
- The Assignor hereby transfers, assigns and sets over to the Administrator all of his/her/their right, title and interest in the proceeds to be received from the BRM program in the current year and, where the BRM Program is AgriStability, all future years until such a time as the advance, in the amount of the outstanding advance, plus interest and costs, for which this BRM program is used as security, has been paid in full, and a liability to the Administrator no longer exists. This assignment of proceeds could be affected should the Producer become in default under the Repayment Agreement. For the purposes of giving effect to any of the Assignor's undertakings under this agreement, the Assignor shall make, execute, and deliver to the BRM Administrator or the Administrator, any documents, or agreements as the BRM Administrator may reasonably request.
 - The amount of the advance(s) will be confirmed to the BRM Administrator by AAFC via the APP Electronic Delivery System or an alternative method agreed upon by AAFC and the BRM Administrator.
 - The Assignor allows the BRM Administrator to share information with AAFC and the Administrator via the APP Electronic Delivery System or an alternative method agreed upon by AAFC and the BRM Administrator.

- The Assignor allows the Administrator to retrieve and verify any information from AgriStability required to complete the Assignor's Advance.

The information collected may include insurance information such as coverage levels, production/inventory reports, claims and income/expenses related to my business or farming operation. a) the BRM Program administrator may collect my information, including personal information within the meaning of The Freedom of Information and Protection Act, from the Administrator and AAFC for the purpose of AAFC's Advance Payments Program. B) AAFC and the Administrator may use this information to verify and assess the Application and Repayment Agreement, as well as to administer, audit, analyze, and evaluate the Advance Payments Program. c) the Assignor acknowledges the BRM Program administrator may also collect and disclose corporate information for these purposes.
- Where the BRM Program payment is the result of a Reseeding Benefit and the Producer has suffered a loss prior to the associated reseeded deadline, as established by the BRM Program administrator, the full payment will be provided to the Producer in order that they are able to reseed and ensure that they continue to qualify for a full crop insurance indemnity should additional losses be experienced.

4. Disclosure

The Assignor hereby authorizes:

- the BRM Administrator to share information, including personal information within the meaning of *Personal Information Protection and Electronic Documents Act (PEPEDA)* or legislation applicable within their jurisdiction, with AAFC and the Administrator via the APP Electronic Delivery System or an alternative method agreed upon by AAFC and the BRM Administrator, for the purpose of administering the APP. The information collected may include, but not limited to: insurance information such as coverage levels, production/inventory reports, claims and income/expenses related to his/her/their business or farming operation.
